The Menard County Board of Commissioners met on Tuesday, **September 29, 2020** at 6:00 p.m. at the Menard County Courthouse, 102 S. Seventh Street, Petersburg, Illinois. Commissioners Bob Lott, Jeff Fore, Allan Anderson and Troy Cummings were physically present. A quorum was present. County Clerk Marty Gum, County Coordinator Dara Worthington, State's Attorney Gabe Grosboll and Sheriff Mark Oller were also present. Commissioner Ed Whitcomb and County Treasurer Pam Bauser were both absent.

Chairperson Lott called the meeting to order at 6:00 p.m.

Commissioner Anderson moved to approve the minutes from the September 8, 2020 Regular Board Minutes and Executive Session Minutes, along with the monthly Departmental Expense report for August. Commissioner Fore seconded the motion. The motion carried with four 'ayes', no 'nays' and one absent.

Anne Smith from the Menard County Housing Authority was in attendance and presented a survey for individuals present to complete and turn in for the comprehensive plan for the City of Petersburg and discussed Lukin's Landing rehab project.

Attorney Jerry Tice via telephone, and Chris Schirding, member of the Petersburg Rural Fire Protection District, both discussed the County zoning issue regarding the placement of propane tanks within the Petersburg Rural Fire Protection's District. A discussion ensued and resulting in the decision that any proposed changes will need to go before the Planning Commission and Zoning Board before being approved. Brian Hollenkamp, Zoning Administrator, will begin to organize the boards.

County Engineer Corey Dowd was in attendance and updated the Board on the following: the progress of right of way on Athens Blacktop, the Douglas Street project, and the Price Street Bridge work beginning on October 12, 2020.
